# Notice: FMCA Officer Elections- January 13 2020~~~~~~~~~~~~~~~~~~FMCA Bylaws

#### ARTICLE IV – OFFICERS

Section 1 The officers of the Association shall be: President, Vice-President, Secretary, Treasurer

Section 2 Officers shall be elected annually by a majority of the votes cast at the regularly scheduled January General Meeting. The first item on the agenda shall be the elections. Nominations shall be made by a Nominating Committee of three current members elected by the membership at the October general meeting. Nominations also may be made from the floor after announcement of the Nominating Committee's nominee for each of the four offices. Nominations shall not be closed until the general members have an opportunity to nominate candidates from the floor. Each nominee shall be given five (5) minutes to state his or her qualifications and present a platform. Voting will immediately follow the close of nominations for each office. Outgoing officers shall deliver all records to the respective incoming officers at the conclusion of the meeting.

Section 3 Vacancies occurring in an office before the end of term, with the exception of Section 5 below, shall be filled by election by a majority vote of current members. Such officer shall serve until the end of the unexpired term.

Section 4 Working closely with the Executive Board and general membership, the President shall provide the leadership to develop and accomplish the goals and objectives of the Association as approved by the membership. The President shall preside at meetings of the Association as facilitator through the democratic process and may call special meetings and appoint ad hoc committees.

Section 5 In the absence of the President, the Vice-President shall perform the duties of President. Upon the President's resignation, removal or inability to perform the duties of office, the Vice-President shall become President until the next annual election of officers. The Vice-President shall be responsible for representing the interests of the general membership, for assisting the President in facilitating the democratic process and for carrying out the decisions of the members.

Section 6 The Secretary shall keep, in permanent form: the minutes of the Association and the Executive Board, a list of committees and their members and a record of attendance at all meetings to be provided by the Membership Committee chair. The Secretary also shall conduct the correspondence and maintain the official administrative records of the Association.

Section 7 The Treasurer shall receive all monies, pay all legitimate bills, and prepare a financial report to be submitted at each regular meeting. The Treasurer also shall disburse funds as directed by majority vote of a quorum of members at a scheduled meeting. Amounts of less than two hundred dollars (\$200) for legitimate, receipted expenses shall not require a vote but may be disbursed at the Treasurer's discretion. All checks drawn on the Association account shall bear the signatures of two officers of the Association. The Treasurer shall be responsible for maintaining official financial records of the Association and an alphabetical roster of members, for ensuring the appropriate and legal disbursement of the Association's funds and for arranging an annual independent accounting review of the Association's financial records.

# Fort Morgan Peninsula Neighborhood Safety & Crime Report ~~~~Corporal Bill Bedgood, BCSO

During the Spring and early Summer of 2019, the Baldwin County Sheriff's Office started receiving multiple reports of home burglaries along a mile stretch of Fort Morgan Rd. Several unoccupied and occupied residences were entered during nighttime hours. Video surveillance was obtained and disseminated to the community and media in an attempt to identify who the suspect or suspects were. Deputies also stepped up patrol efforts, in the area, to put pressure on the suspect. The number of burglaries in the area slowed down and eventually ceased in the areas patrolled by the Sheriff's Office.

During August of 2019, the Gulf Shores Police Dept., started having burglaries occur in their jurisdiction that were similar to the burglaries that occurred further down Fort Morgan. Investigators with BCSO and GSPD teamed up to search for and arrest the suspect. The suspect appeared to be living in the woods where the burglaries were occurring. The suspect would break into and stay in

unoccupied summer homes for a period of time and then pick up and move to another home. There were sightings of the suspect around September of this year that led to several manhunts in the area. The suspect was able to elude law enforcement on every occasion.

In October of this year, investigators were able to put a name to the face that had been seen on video during the Gulf Shores investigations. The suspect was identified as Joseph Reed. It is believed that Reed left the Fort Morgan area and went to the Yupon area West of Magnolia Springs. Additional thefts and burglaries started occurring in this area that closely matched Reed's methods from Fort Morgan. There were three manhunts in this area in an attempt to arrest Reed for the criminal activity. Each time, Reed was able to elude capture due to terrain and his familiarity with the area. During one of the manhunts, Reed discarded a loaded firearm.

On November 18, 2019. Investigators with the Baldwin County Sheriff's Office received information from the public that Reed would be at Flamingos gas station in Foley (US 98/Foley Beach Express). Investigators and Patrol units watched the business until Reed arrived in a vehicle. Reed immediately ran from the vehicle into a neighboring mobile home park. Reed was eventually taken into custody after a brief foot chase. Reed was treated for a head injury at South Baldwin Regional and then transported to the Sheriff's Corrections Center. Reed is currently facing several charges. Additional charges are forthcoming from multiple law enforcement agencies. Reed has prior theft and burglary convictions.

Additional charges were brought against Reed following this press release, including manufacturing and possessing child sexual abuse material. Reed will be charged with more property crimes relating to the Fort Morgan Road area this week.

# Sea Turtle Lighting – Follow up to the 20 November Workshop~~~Susan West, Alabama Coastal Foundation





#### Sea Turtle Lighting Issues along the Alabama Coastline

Sea turtle nesting and hatching season is May 1 – Oct 31. During this time, sea turtles can become confused by artificial light. Nesting females may not come ashore to nest or may become disoriented while making their way back to the water due to artificial lights on condos, houses and beachfront businesses. Hatchling turtles are attracted to these lights as well and can get confused and end up in the dunes, in the roads or be eaten by predators instead of reaching the safety of the Gulf.

All species of sea turtles are protected by the US Fish and Wildlife Service (USFWS) endangered species act. Changing out or retrofitting exterior lighting to sea turtle friendly is the more effective way to have the most impact and reach USFWS compliance. You can also help mitigate lighting issues by turning off all interior lighting that faces the beach or simply closing curtains to minimize the effect of indoor lights.

Alabama Coastal Foundation was approached last year by the National Fish and Wildlife Foundation to create a sea turtle lighting retrofit pilot project to help private landowners navigate the complex process of changing their lights to ones that are more sea turtle friendly and meet federal compliance guidelines. This past summer ACF worked with two single-family homeowners to address lighting issues on Mobile Street on Fort Morgan. They also worked with a condominium and a business in Gulf Shores. The results are remarkable. Reduction in light levels reached upwards of 50-100% in most of the cases.

#### Why should my property change our lights?

- It is the right thing to do to have lights that are both effective for human safety and does not have a negative impact on sea turtles (as well as other animals).
- *It's the law.* All sea turtle species in the state are protected under the Endangered Species Act of 1973. Having lights that disorient turtles is a violation of that Act and could result in fines of up to \$25,000 per nesting turtle or hatchling.
- It is a good time. Technology has improved greatly over the past two decades and there are more options from which to find a good and affordable solutions.
- Local people and tourists see the connection between why people spend their time and financial resources in Alabama's coastal environment!

# What steps do I take to become sea turtle friendly?

- Conduct daytime evaluations to identify and inventory all lighting on your property.
- Conduct nighttime evaluations to determine what lighting is visible from the beach. Be sure to look at your property from all directions.
- Develop a detailed lighting plan to outline all lighting issues and applications.
- Work with lighting specialists to determine best lighting solution to meet human safety and federal sea turtle friendly requirements.
- Have all plans approved by USFWS prior to making any purchases or installing any lighting fixtures. Contact Shannon Holbrook, USFWS 251-441-5871 shannon\_holbrook@fws.gov





#### Indian Village Achuse

The following is the inscription on the Historical Marker at Shell Banks Baptist Church. "This Shell Banks Baptist Church rests near the location of the first Indian village in America visited by a white man. This was the Indian village of "Achuse" visited by Admiral Maldonado who was one of De Soto's officers. He scouted the Florida and Alabama coast from Tampa Bay and entered the port of "Achuse" before De Soto started from Tampa Bay on the longest, strangest, boldest adventure in the history of the world. This was in 1539, 81 years before the Pilgrims kneeled at Plymouth Rock and 68 years before the colony landed at Jamestown. The name of this village, "Achuse" is shown at this location on the official map made by the U.S. De Soto Expedition Commission created by Congress in 1936. On an old crude Spanish map made of the Gulf Coast region in the 16th century, the Indian village of "Achuse" shows on this map near the same location, now occupied by the Shell Banks Baptist Church." The name Shell Banks comes from the oyster and clam mounds that were on the site. The Historical Marker was erected in 1966 and is located at 30° 15.104' N, 87° 48.938' W., on Alabama Route 180 east of Gasque Lane, on the right when traveling west.
